An application for the holding of a trial shall be made no later than January 1. An application for a fall trial shall be made no later than August 1.

The prospective permittee shall maintain public liability and property damage insurance for the requested period of use, with an insurance company recognized to do business in the State of New Jersey, in the amount of \$100,000/\$300,000 personal liability and \$50,000 property damage. ***A certificate for such coverage shall be submitted with each permit application.***

All persons shall use every precaution to prevent damage, destruction, or fire. The permittee shall be completely responsible for any damage occurring in the location of and during the times of the trial being conducted. No permit shall be issued to any organization or persons who have damaged or destroyed State lands or property and who have failed to reimburse the State.

The organization or persons sponsoring the event shall be responsible for the removal of all litter, cleaning of clubhouses including kitchen and bathroom facilities, removal of all trash from the wastebaskets, trash cans and refrigerators in the clubhouse, cleaning of horse manure and dog manure in the areas surrounding the clubhouse fence and parking areas. The permittee shall be billed by the State for any expenses necessary to clean the facilities after the use by the permittee. No future permits shall be issued to any organization or person who has failed to reimburse the State.

ALL PERMITTEES ARE REMINDED THAT THE USE OF ALCOHOLIC BEVERAGES IS STRICTLY PROHIBITED ON STATE OWNED LANDS AND FAILURE TO ABIDE BY THIS COULD RESULT IN PENALTIES AND THE LOSS OF FUTURE PERMITS.

The specified club or organization agrees to conform and abide by the rules and regulations concerning the issuance of field trial permits as stated in Regulation 7:25-2, Use of All Lands and Water Areas Under the Control of the Division of Fish and Wildlife for Field Trial Activities.
